Pursuant to Article 133 of the Air Traffic Law ("Official Gazette of RS", No. 73/2010, 57/2011, 93/2012, 45/2015, 66/2015 - second law, 83/2018, 9/ 2020 and 62/2023), Article 7, Paragraphs 3 and 4 of the Rulebook on Airport Fees ("Official Gazette of RS", No. 71/2013, 48/2016 and 96/2017) and Article 16 of the Decision on the incorporation of a Business Company no. GD — 3996 /2019 dated 22/07/2019 clean text), on 31/10/2023, the Chief Executive Officer of BELGRADE AIRPORT d.o.o. Beograd, 11180 Belgrade-Surčin, Aerodrom Beograd No. 47, Republic of Serbia (hereinafter referred to as: the Company) issues the following:

DECISION

on the adoption of a new /

amended incentive plan for increasing the volume of traffic at Nikola Tesla Airport in Belarade

- 1. The Incentive Plan for increasing the volume of traffic at Nikola Tesla Airport in Belgrade is hereby approved, enclosed hereto (hereinafter: the Incentive Plan).
- 2. This decision enters into force and shall be applicable from January 1, 2024, when the implementation of the Incentive Plan under article 1 hereof shall commence.
- 3. On the date of entry into force and the implementation of this decision, the Incentive Plan for increasing the volume of traffic, BELGRADE AIRPORT d.o.o. Beograd, 08 no. GD - 755/2023 dated 31/03/2023 (applicable as of 01/04/2023) shall be revoked.
- 4. Hereof decision shall be published on the bulletin board and the Company's website on 31/10/2023
- 5. The OU Commercial affairs and marketing is responsible for the implementation of this decision.

Explanation

BELGRADE AIRPORT d.o.o. Beograd with its activities, strives to effectively adapt to new trends and through its own development stimulates faster recovery and development of the aviation market.

The aim of BELGRADE AIRPORT d.o.o. Belgrade is to, through the new (amended) Incentive Plan, create conditions for the accelerated recovery of air traffic, continue the development of the regional hub concept, facilitate connections with new markets, both short/medium-haul and intercontinental traffic.



In accordance with Article 7, paragraph 3 and 4 of the Rulebook on Airport Charges of the Republic of Serbia ("Official Gazette of the RS", no. 71/2013, 48/2016, 96/2017), hereinafter: Rulebook, and in connection with Article 133 of the Air Traffic Law of the Republic of Serbia ("Official Gazette of the RS", no. 73/2010, 57/2011, 93/2012, 45/2015, 66/2015. - other Law, 83/2018 and 9/2020), BELGRADE AIRPORT d.o.o. Belgrade held consultations with airport users regarding changes to the Incentive Plan for increasing the volume of traffic.

BELGRADE AIRPORT d.o.o. Beograd had notified all airport users (airlines) on the planned changes to the Incentives Plan for increasing the volume of traffic, by delivering a letter GD No. 2899 dated September 29, 2023, to all parties interested thus commencing the consultation process.

At the meeting of the Air Carriers Committee held on October 24, 2023, pursuant to the Article 7, Paragraph 3 of the Rulebook on Airport Charges and due to exceptional circumstances which BELGRADE AIRPORT had justified to airport users, Belgrade Airport proposed reducing the consultation period referring to Incentive Plan amendments, enclosed in the draft of the new Incentive Plan, whereby the consultations shall last until October 31, 2023, and the decision on adopting the new Incentive Plan, i.e. the new (amended) Incentive Plan shall enter into force on January 1, 2024.

At the meeting of the Airline Carriers Committee held on October 24, 2023, the Committee had accepted the proposal of BELGRADE AIRPORT d.o.o. Beograd that the consultation period regarding the changes in the amount of airport charges enclosed in the draft of the new Incentive Plan, shall be adjusted and shall last until October 31, 2023 (Minutes from the meeting of the Airline Carrier Committee dated 10/24/2023 and 31/10/2023, enclosed hereto).

The process of consultation with airport users regarding the Proposal for a new (amended) Incentive Plan was completed at the meeting of the Air Carriers Committee held on October 31, 2023, as per the conclusion of the Committee of no objections being established to the submitted Proposal for a new (amended) Incentive plan (Minutes from the meeting of the Air Carriers Committee held on October 31, 2023, enclosed hereto).

Taking into consideration all the above, it was decided as in the enacting clause.
