### 1. GENERAL CONDITIONS

### 1.1. General

Hereof, the Price List for access to service and auxiliary service roads at BELGRADE AIRPORT defines services and conditions applicable to services listed hereunder and provided by Belgrade Airport d.o.o. BELGRADE AIRPORT Nikola Tesla Beograd.

This price list enters into force on 01/09/2025 and completely replaces the Price List for Access to Service and Access Roads No. 1790-2024 dated August 30, 2024.

The service user is deemed to have fully accepted this Price List and its conditions upon commencing the use of any service defined hereunder.

The Service user has the meaning given in points 2.1, 2.2, and 3.1 of this Price List.

Calculating and collecting charges for services used is conducted in EUR and RSD.

For domestic users, billing is conducted in RSD, which is equivalent to the official middle exchange rate of the NBS on the day of the tax liability.

All prices listed in the Price list are shown without value-added tax.

Payment must be made with tax included if conducted for the service subject to taxation.

### 2.1. Charges for access and use of service roads and auxiliary service roads

BELGRADE AIRPORT d.o.o. Beograd enables airport infrastructure access to ground handling service providers, other service providers, airlines, and third parties with valid permits for movement in the critical part of the security-restricted zone.

A passenger vehicle is a motor vehicle intended for the transport of passengers, which, in addition to the driver's seat, has a maximum of 8 seats.

Aircraft handling vehicles are vehicles of special purpose that participate directly in aircraft ground handling.

A commercial vehicle is a motor vehicle designed and constructed to transport goods or tow a semi-trailer (excluding aircraft ground handling).

Other vehicles are vehicles that are not included in the definition of passenger, cargo, and aircraft ground handling vehicles, and a set of vehicles (composition of towing and trailer vehicles).

## 2.2. Charges for the use of service roads and auxiliary service roads for the delivery of aircraft fuel

BELGARDE AIRPORT d.o.o. Beograd enables access to the airport infrastructure for the providers of aircraft fuel delivery services as required by airlines, within the critical part of the security-restricted zone.

As per prices listed hereunder, and based on the turnover of service users, BELGRADE AIRPORT d.o.o. Beograd may grant a price reduction according to the discount scale enclosed hereto (A Scale of discounts according to the number of vehicle passes or B Scale of discounts according to the amount of fuel delivered by air carriers) in the attachment of the Price List.

## 3. CHARGES - STAY OF VEHICLES / EQUIPMENT

# 3.1. Charges for the stay of vehicles and equipment when not engaged in ground handling of aircraft.

BELGRADE AIRPORT provides ground handling agents the areas intended for the stay of equipment and vehicles when such are not used for ground handling services is the space intended for vehicles, facilities, and equipment not engaged in the ground handling process, designated for the specified purpose, in accordance with the needs of the Parties.

Vehicles and equipment that are not engaged in ground handling of aircraft shall be charged as per the area occupied by the vehicle/equipment according to the list of equipment/vehicles that shall be delivered by the airport user. Any changes concerning the list of equipment/vehicles must be delivered by the airport user within 30 days following such change. Each commenced month from part 3.1.1 and 3.1.2 shall be calculated as a full month of service.

The stay is charged for vehicles/equipment that do not leave critical parts of the security-restricted zone for each month started.

## 4. ATTACHMENT OF THE PRICE LIST - Reduction scale for services from point 2.

For services from point 2. of this Price List, BELGRADE AIRPORT d.o.o. Belgrade can approve a price reduction from this Price List, based on the number of vehicle passes/the amount of fuel delivered to the service user, according to the following reduction scale:

### A): Discount scale according to the number of vehicle entries

### Method of application:

Approved reductions for the number of passes are paid every month by reducing the invoice for services from point 2. of this Price List.

### Method of application:

Approved discounts for the quantity of delivered fuel are paid at the end of the year through credit notes based on the realised turnover during the previous year.

The discount for the amount of delivered fuel at the end of the calendar year is calculated according to the applicable scale for that year.
